Any student who fails to appear before the Faculty Screening Committee within the stipulated period stands risk of not graduating on schedule and will, in addition, pay a fine of **N3000.00** for late screening.

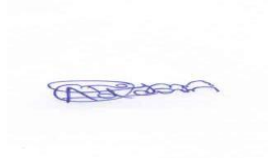
You are advised seriously to abide by the above directives, as flimsy excuses for not being available would not be entertained by the Committee.
